Entries will not be accepted without signature, fees and entry forms. No refunds after limit is reached except for bitches in season. Veterinarian statement must accompany request.

- ☞ Running order will be: Saturday AGI, AGIII, AGII; Sunday AGII, AGIII, AGI.
- ☞ Rosettes will be awarded for High in Trial and High Combined, and for first through fourth places in each division. No awards will be mailed.
- ☞ These trials are open to dogs at least six months of age registered with the United Kennel Club.
- ☞ No X-pens.
- ☞ No bitches in season allowed on the premises.
- ☞ The safety of the dogs is our primary concern. By entering this trial, exhibitors acknowledge that they are familiar with the UKC rules and regulations of this sport. It is expressly understood that exhibitors alone are responsible for the behavior of their dogs and/or children. Any exhibitor whose dogs and/or children create unnecessary disturbances or repeatedly engage in unsafe or disruptive behavior may, at the discretion of the Show Committee, be asked to leave the show site. In such cases, no refund of any fees paid will be made.
