Armbands: Unless you noted on your entry form that your dog needs to be measured, your armband will be available at the check-in table, along with course maps for the day. If you noted on your entry that your dog needs to be measured, your dog will need to be measured before you run. There will be VMOs in attendance all three days. If you run and are not measured the AKC will remove any legs you may have earned this weekend.

Site Rules: Clean up after your dog, both at the site and at the hotels. Dogs are not permitted off leash outside the building or permitted on any of the outdoor grassy areas except for the marked exercise area. Please use the designated exercise area ONLY. Otherwise this site may not be available to us for future trials. Violators will be excused from the trial without refund.

Parking: Park at the northwest end of the sports complex. There will be signs showing where to enter.

Crating: Crating areas will be marked. Crate in designated areas only. Please bring a mat or blanket to place under your crate to protect the floor.

The site will NOT be available for set up Thursday.

Food: The sports complex has a snack bar and fast food is available nearby.

Workers: A worker schedule will be posted on the club website (wagagility.com).
