Treasurer (Shelly) – Checking account balance is \$16,033.06, the money market balance is \$105,806.83 (not including the AKC deposit from earlier this month) , and the SBA loan balance is \$34,506.83.

Building Maintenance (Mike/Greg/Kelly) – No updates

Building Rental (Judy/PJ) – Rates were increased 5% for rental; deposit policy was left the same for the time being.

Class Registration (Diane/PJ) – Registration for session 2 started on February 9th for members and instructors. It is too early yet to know if there will be an issue of classes filling or not.

CPE Agility (Shelly) – Still waiting on Jennifer's contract for December 2026.
